Oregon Studio Group LLC Wedding Contract Agreement

1 ENTIRE AGREEMENT

This agreement contains the entire understanding between Oregon Studio Group LLC and the client. It supersedes all prior and simultaneous agreements between the parties. The only way to change or add to the agreement is to do so in writing, and providing the document is signed by all the relevant parties.

2 PRICING

The collection price is guaranteed for your wedding event for a period of one year. If more hours are added after the contracted is signed and the retainer paid, all additional hours will be added at the current published rate.

3 PRE-EVENT CONSULTATION

Pre-event consultations are required for the client before the event date to finalize the actual shooting times and locations. If the client is unable to do an in-person meeting, the event details can be communicated via phone, video chat, or email.

4 WEDDING COORDINATOR OR EVENT GUIDE

If the ceremony or reception provides a “Wedding Coordinator or Event Guide”, the client is responsible for communicating all the information to Oregon Studio Group LLC prior to the wedding day. This information includes but is not limited to the timeline, itinerary, schedules, etc. One month prior to the wedding date, Oregon Studio Group LLC will provide the client with a wedding day questionnaire, please return it in a timely manner. The client will be responsible for (or have someone designated for this responsibility) identifying people and objects of which specific photographs are needed at the wedding event. Oregon Studio Group LLC will not be held accountable for not photographing the desired people if there is no one to assist in identifying or gathering people for photograph(s). The client is also responsible for identifying any individuals that do not want to be photographed. This list will need to be created and delivered to Oregon Studio Group LLC before the day of the ceremony.

5 PERMISSIONS

It is the clients’ responsibility to schedule and receive permission to use various locations for photography, including the wedding and reception locations and any other locations used during the day. Should a location require a payment, this payment will be paid by the clients.

6 EXCLUSIVITY

Oregon Studio Group LLC and their associates shall be the exclusive photographers retained by the client for the purpose of photographing the wedding. Family and friends of the clients and other wedding vendors shall not interfere with the photographer’s duties. Guests will be asked to refrain from taking flash photographs at certain intervals of the wedding services to ensure proper exposure of the photographer’s images. Additional professional photographers may be employed only with prior written permission from Oregon Studio Group LLC. Guest photographers may not be active during the ceremony and will not be allowed to photograph during family and individual portraits. Oregon Studio Group LLC spends special time planning and posing your photographs and asks that guests do not intervene.

7 SECOND SHOOTER

If a second shooter is used for the event, please note that they will be there for time selected by Oregon Studio Group LLC. Second shooters may not be there for the entire day depending on the needs of the photographer.

8 OVERTIME

Oregon Studio Group LLC charges \$350 per hour for each overtime hour beyond the full coverage window specified in the contracted collection. All overtime charges will be billed to the client after the event and no images will be delivered until it is paid.

9 GARMENTS

Oregon Studio Group LLC cannot be held responsible for damage to garments for any reason. The client is responsible to arrange personal assistance for wedding garments.

10 CREATIVE LICENSES

Images may be edited at the photographer's discretion and delivered images may not include all images shot. Oregon Studio Group LLC reserves the right to edit and release only those images deemed of professional quality and within the photographer's professional artistic standards.

11 RETOUCHING

Basic retouching will be added to all images. Basic retouching includes global adjustments such as white balance, color correction, exposure, contrast, clarity, etc. Basic retouching will also include skin and beauty retouching and any other things seen that need to be fixed by the photographer that fall into a basic retouching category. It is at the photographer's discretion as to what is classified in the basic retouching category. If the client decides they would like more extensive retouching after they receive their gallery of images, any additional extensive retouching will incur an extra charge. Examples of extensive retouching would be any body sculpting or weight changes, extensive blemishes, extensive beauty retouching, etc.

12 RECEIVING DIGITAL IMAGES

Images will be ready to deliver 6-8 weeks after the wedding. Your images will be delivered via an online sharing service and gallery. Any prints or products ordered will be delivered shortly after.

13 STORAGE OF IMAGES

Oregon Studio Group LLC highly recommends the client create backups and makes multiple copies of all their images to another media format after receiving the digital images. Oregon Studio Group LLC cannot be held responsible for the failure of any digital backups. It is the client's responsibility to keep several copies of any digital or hard copies of images in more than one location and back up the images on another format such as a hard drive. Once the images are in the hands of the client, it is the client's responsibility to save and protect them for the future.

14 PURCHASE OF PRINTS OR ALBUMS

Oregon Studio Group LLC does not guarantee the quality of any print, album or other photographic product not acquired through Oregon Studio Group LLC. If the client desires professional quality prints, they may be purchased through Oregon Studio Group LLC at the current published price.

15 COPYRIGHTS

All photos created by Oregon Studio Group LLC are copyright protected. It is a violation of federal copyright law to copy, scan, or allow photographs created by Oregon Studio Group to be reprinted, duplicated, digitally reproduced, copied, scanned, or altered digitally or otherwise, without Oregon Studio Group LLC's express written permission. The digital files remain the sole property of Oregon Studio Group LLC. Oregon Studio Group LLC has the nonexclusive, perpetual, irrevocable, and worldwide right to use, to crop, to modify, to reproduce, and to distribute the photographs in print, and in all other formats, methods and technologies of distribution of any kind, now known or later developed. The client may print their personal wedding photographs with the written consent of Oregon Studio Group LLC only after they have received possession of the digital images.

All clients will receive a written print release along with their digital files when all balances have been paid in full. The print release will allow the client to display the images, print the images, publish the images on personal websites or social media websites, upload, email, or electronic transfer the images and files. This release does not give the client permission to copyright or sell any image or digital file created and supplied by Oregon Studio Group LLC.

16 RETAINER AND FEES

A non-refundable retainer fee of one third (1/3) the cost of the selected collection is required to hold the date of your wedding. No date will be reserved until a retainer is received. The balance of the complete collection price must be paid 30 days before the date of the wedding. If final payment is not received as set forth herein, Oregon Studio Group LLC reserves the right to withhold delivery of the images and/or not attend the wedding until payment is received. Upon payment of the retainer fee and the client's signatures on this contract, Oregon Studio Group LLC agrees to reserve the date and time specified by the client. The retainer fee is applied towards the final contracted wedding collection and is not in addition to the collection selected. Once the contract is signed, the retainer must be provided within 3 business days from the date of signing this contract. If the retainer is not received within 3 business days from the signing of the contract, the contract becomes null and void and is canceled. The date will be released for other couples to book.

17 EXPENSE REIMBURSEMENTS

The client agrees to reimburse Oregon Studio Group LLC for all reasonable expenses directly related to the wedding event. These shall include but not limited to parking fees, travel fees, lodging fees, etc. Oregon Studio Group LLC will bill the client after the event. Any anticipated expenses will be discussed with the client prior to the wedding event. Copies of receipts or documentation will be provided with the bill.

18 CHANGE OF DATE OR VENUE

Oregon Studio Group LLC must be notified immediately of any changes in schedule or location, at least two weeks prior to the scheduled date of the event. Notification of any changes can be made by phone along with a written notice sent via email. If an email is sent, a confirmation of receipt of that email by Oregon Studio Group LLC must be in writing. It is the client's responsibility to confirm all arrangements at least 14 days in advance and again at 7 days in advance prior to the event. In the event of a change of address, contact information, time, etc. as listed, the client will immediately notify Oregon Studio Group LLC. Changing the date is subject to fees and the availability of the date.

The client is personally responsible for all location fees and permits including any location fees or permits that are charged by the venues for the photographer. The client agrees to furnish Oregon Studio Group LLC written documentation that all such fees have been paid prior to the actual wedding date.

19 CANCELLATION

There shall be no refund of the retainer after 48 hours from the actual receipt of the retainer. Once the balance is paid, it is NON-REFUNDABLE. Any other arrangements shall be discussed between the client and Oregon Studio Group LLC. All arrangements will be put in writing. Cancellation must be in writing even if a phone call was made to inform Oregon Studio Group LLC of the cancellation. The retainer fee will be transferable up to 1 year (365 days) after the cancellation. The client further understands that a new date is subject to Oregon Studio Group LLC's availability. The client will be given the opportunity to reschedule but will not be pushed ahead of other reserved clients. Some fees may apply for rescheduling.

If cancellation of the wedding or with the photographer is within 30 days of the scheduled wedding date, the ENTIRE balance is due in FULL. Please be reminded that once a date is reserved all other inquiries and bookings are refused for that specific date. In doing so any potential clients are forfeited and therefore the balance IN FULL is still due. In rare cases where the date can be booked, the monies received, minus the 1/3 initial retainer fee will be returned.

20 SUBSTITUTION

In the event of illness or a sudden event out of the control of both parties, Oregon Studio Group LLC will attempt to substitute a photographer at no cost to the client. This contract will be transferable to said photographer. This photographer will shoot the event and then Oregon Studio Group LLC will still make every attempt to edit the selected file for the clients.

21 FAILURE TO PERFORM

Due to the limited and subjective nature of weddings, Oregon Studio Group LLC cannot be held responsible for requested photographs not taken or missed, lack of coverage resulting from weather conditions, or schedule complication caused by but not limited to, anyone in or at the event, or by the church or location restrictions. Oregon Studio Group LLC is not responsible for lost photo opportunities due to any kind of equipment malfunction, the lateness of the event couple, family members, members of the bridal party or other principles. The photographer is not responsible for the lack of coverage due to weather conditions, scheduling complications due to the lateness of individuals, rules and restrictions of the venue, or the rendering of decorations at the location. It is acknowledged that any lists submitted to Oregon Studio Group LLC will be used for organizational purposes only and in no way represents photography that will actually be produced although every effort will be made to follow it. Oregon Studio Group LLC will do our best to fulfill all requests but cannot guarantee all images will be delivered.

22 FORCE MAJEURE

If Oregon Studio Group LLC cannot perform this agreement due to fire, casualty, strike, civil disturbances, Acts of God, pandemics, including but not limited to, road closures, severe traffic, fire, terrorism or other causes beyond the control of the parties or due to the photographer's illness, then Oregon Studio Group LLC shall return all monies paid by the client, and shall have no further liability with respect to the agreement. This limitation of liability shall also apply if photographic materials are damaged in processing, lost through camera malfunction, digital flash card malfunction, or otherwise lost or damaged without the fault on the part of Oregon Studio Group LLC.

23 LIMITATION OF LIABILITY

Oregon Studio Group LLC does not make any representation or warranties of any kind to the client, either expressed or implied, as to any matter in connection with this agreement, the services, the photographs, or products, in no event shall Oregon Studio Group LLC be responsible for incidental, consequential, punitive, exemplary, special, or indirect damages in connection with this agreement, the service, the photographs, and/or the digital negatives including, but not limited to lost monies.

The client further relieves Oregon Studio Group LLC from: Any action, claim, command, obligation, cause of action, damages, costs, loss of service, expenses and compensation of any kind or nature whatsoever brought by any third party against the client arising out of any action of the client and/or other third parties during the execution of this contract with Oregon Studio Group LLC. Any and all claims, demands, or actions which may hereinafter or at any time be made or brought against Oregon Studio Group LLC by any person or entity who has made or agreed to make payment on the client's behalf for any medical expense or any other obligations incurred by the client as a result of property damage, bodily and personal injuries, illness, paralysis and or death to the client or any members of the client's family arising out of Oregon Studio Group LLC's activities.

24 ACKNOWLEDGEMENT AND SIGNATURES

The undersigned hereby acknowledges that they have received, read, and understand this contract and its contents. Permission is hereby granted to Oregon Studio Group LLC to use any images created under this contract for professional samples, displays, website pages, advertising, exhibitions, contests and for any other purpose.

The laws of the State of Oregon shall govern this contract. All parties understand and agree to all that is stated above. The client(s) agree to only sign if they have read and agreed to the terms of service in this contract and they believe all information is deemed correct to the best of their knowledge.
